


The adoption of this technology will occur at different times for different stages and processes of the supply chain, but ultimately all these technologies will converge, linking with and between each other to transform the diamond industry supply chain.

### Hardware:


RFID tagged diamonds or jewellery are placed and/or stored in SpaceCode's specially designed smart devices – SmartBoxes, SmartCabinets and SmartSafes. The smart devices use SpaceCode's advanced RFID technology to communicate with the software and network. This data provides all the information regarding what inventory is in the smart device at any point in time, who handled the inventory, when and where. The PLEXUS<sup>TM</sup> RFID system continuously scans and knows its contents. Uniquely, it can read thousands of diamond parcels stacked in very close proximity in any orientation with 100% reliability, in a secure system that is easy to use. The smart devices can be deployed globally anywhere in the office or factory, on desktops, or remarkably even in safes - no one else can equal the physics of this RFID performance. Units can be stacked as a single unit or as multiple units on top of each other. When located in the safe, the SmartSafe continues to function even when the safe is closed. This means that it operates as an intelligent safe within a safe, allowing wholesalers, manufacturers and retailers to track their diamond stock, value and other information no matter where they are in the world. A biometric/finger print identification system is needed for access to any of the smart devices.

### **Software:**



Stones, movements, and transactions are monitored and analysed in real time. Alerts are triggered when unusual or prohibited activity occurs such as when a door is left open too long, removal of exceptionally valuable items or removal of goods beyond the permitted value limit. The software provides business intelligence allowing better and faster decisions to be made and can also generate real time activity reports and data in regard to any stock movement:


- Total inventory and its value
